After verification and completion of necessary formalities, the amount payable on <u>9th</u> <u>September, 2020</u>, will be remitted through RTGS/NEFT/NACH/DD/Pay-Order which will be sent by registered post/speed post at the address and in favor of the Holders whose name appears first in register of Bondholders as on <u>9th</u> <u>August, 2020</u> in list of beneficiaries appearing in the records of NSDL/CDSL as on Record Date. The Bonds shall be taken as discharged on payment of interest cum call option amount by the Bank as aforesaid. Such payment will be a legal discharge of the liability of the Bank towards the Bondholders. On such payment being made, the Bank will inform NSDL/ CDSL and accordingly the account of the Bondholders with NSDL/ CDSL will be adjusted.

Bank's liability to the Bondholders towards all their rights including for the payment or otherwise shall cease and stand extinguished from the call option date.

Further, Bank will not be liable to pay any interest or compensation from the call option date. On the Bank dispatching / remitting the amount as specified above in respect of the bonds, liability of the Bank shall stand extinguished in all respects.
